
This is the first winter that Pepperidge will be handling our snow removal services. The Board and Landscape Committee have had discussions with Pepperidge about costs and

what we expect for quality of service. As it gets colder, there will be markers placed to guide the plows, both for the road and the driveways. We will have further road and snow removal updates, as they become available.

You are responsible for the sensible use of de-icing agents on the cement walk and driveway from your condo to the road. Treating ice and snow can improve traction and safety. However, it can also accelerate cement deterioration and other problems. The builders made a point of co-owners not using de-icing agents on those areas for at least the first year. So, this winter, you need to be cautious and find the right balance between too much and too little. (I find that's true for many things in life.)

Of Note:

The Board wishes to thank the Landscape Committee for their diligent work this past season. Landscape issues have been taking a lot of all our time. We are still learning about the COA concept, refining our processes, and making progress. Keep up the good work.
